- 1. 根據《社會工作者註冊條例》第 5(2)條,「註冊局的成員如已連續 9 年擔任成員,或擔任成員的任期如在任何 11 年的期間中超過 9 年,則他不可再擔任成員,直至自他最後擔任成員起計的 2 年期間已過為止。」
 - Under Section 5(2) of the Social Workers Registration Ordinance, "a member of the Board who has been a member continuously for 9 years, or whose period of service as a member exceeds 9 years in any 11 year period, may not again be a member until a period of 2 years since he last served has elapsed".
